Dear Ms. Bose:

In accordance with the requirements of the Interstate Commerce Act and the rules and regulations of the Federal Energy Regulatory Commission (“FERC”), Razorback L.L.C. (“Razorback”) submits for filing the following tariff, effective January 1, 2013:

F.E.R.C. No. 9.0.0 – Local Pipeline Tariff which cancels F.E.R.C. No. 4.2.0
(TransMontaigne Product Services Inc. series)

The above tariff is filed under the authority of 18 CFR § 341.6(c).

Effective November 30, 2012, TransMontaigne Product Services Inc.’s (“TPSI”) tariff was adopted by Razorback L.L.C. Also, a new origin point, the La Gloria Gas Plant, has been added. All rates, rules and routing have been brought forward unchanged except for the company name reference as indicated in Item 2 in the subject tariff.

In addition to adopting TPSI’s FERC tariff, Razorback’s F.E.R.C. No. 9.0.0 is being issued to reflect a new origin point on the system. Razorback is adding the La Gloria Gas Plant in Jim Wells County, Texas, as a new origin point. The new origin point will allow third-parties to ship liquefied petroleum products from the La Gloria Gas Plant on the Razorback system to the TransMontaigne Partners L.P. terminal in Cameron County, Texas. In accordance with 18 C.F.R. § 342.2(b), attached is an affidavit stating that a non-affiliated shipper has agreed to the initial rate of \$0.714 per barrel.

In accordance with 18 CFR 341.2(c)(2), Razorback certifies that this letter and the attached tariff have been sent to all subscribers for this tariff publication. If you have any questions, please contact Seth Belzley at (303) 626-8230.

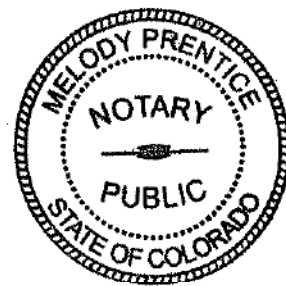
